**INDIVIDUAL INFORMATION**

- SBA Form 1919 -Borrower Information -completed for each principal with 20% or more ownership of the business or anyone hired to manage day-to-day operations of the business as well as any guarantors for the loan **(SBA Form)**
- If Non-US Citizen provide a legible front and back copy of legal resident alien card and complete and sign INS Document Verification Request **(SBA Form)**
- Legible Copy of each principal's Driver's License
- SBA Personal Financial Statement jointly prepared for each owner/guarantor current within 90 days **(SBA Form)**
- Most current 3 years personal tax returns for each owner
- Copy of most recent W-2's if not included in tax return/statements
- Resume for each owner or manager of the business **(SBA Form)**

**BUSINESS INFORMATION:**

- Most current 3 years business tax returns for the business
- Current year to date (within 180 days) Balance Sheet and Profit & Loss for business
- Prior year end Balance Sheet and Profit & Loss for business, if prior year tax return is extended
- Schedule of Debts - list of debt for business **(SBA Form)**
- 4506 T -Request for Tax Transcripts for business **(SBA Form)**

**IF NEW BUSINESS:**

- Business Plan
- Day One Performa Balance Sheet
- Projections/Cash Flow Analysis for first 24 months of operation with description of assumptions **(SBA Form)**

**AFFILIATES:**

- Provide a list of all businesses owned by individuals above, list the percentage of ownership to show a total of 100%, indicate the nature of each business
- Schedule of Debts - list of debt for each business owned **(SBA Form)**
- Most current 3 years business tax returns for each business where ownership interest is 20% or more.
- Current year to date within 180 days) Balance Sheet and Profit & Loss for each business
- Prior year end Balance Sheet and Profit & Loss for each business, if prior year tax return is extended
- 4506 T -Request for Tax Transcripts for each business
