

Notice of Packaging Fee and Deposit Requirements

BDC requires a <u>nonrefundable</u> Packaging Fee for all loan requests to assist the borrower with an SBA application, including the review of business plans, projections and preparing packages for SBA.

This fee must accompany your application for financing. The fee must be received prior to loan committee. This amount will be used as part of borrower equity injection

In addition to BDC's Packaging Fee described above, SBA charges a guarantee fee. If your loan is approved and BDC issues a commitment letter to you, a deposit equal to 1.5% of the loan amount must be submitted with the signed and accepted commitment letter. At closing, this fee will be credited toward the remaining balance due for the required SBA guarantee fee. In the event the loan does not close, a portion or all of this deposit may be applied to costs for BDC, including but not limited to legal fees accrued by BDC's closing attorney.

For Renovations or Construction: A construction loan fees of up to 2% of the construction portion of a loan may also be charged for extraordinary servicing when permissible under SBA guidelines. No other fees are charged by BDC for loans that are approved, closed and disbursed.

By signing this application, the Applicant certifies that it complies with all Loan Program Requirements as defined in 13 CFR § 120.10, including but not limited to requirements in 13 CFR §§ 120.100, 120.110, 121.301, and 31 CFR § 285.13. The Applicant further certifies that the Applicant business is at least 51 percent owned and controlled by persons who are citizens of the U.S. or are Lawful Permanent Residents and that all SBA loan proceeds will be used in accordance with Loan Program Requirements. Right to Financial Privacy Act of 1978 (12 U.S.C. § 3401 et seq.) – As required by the Right of Financial Privacy Act of 1978, SBA provides this notice of SBA's right to access financial records held by financial institutions that are or have been doing business with you or your business, including any financial institutions participating in a loan or loan guarantee. The law provides that SBA shall have a right of access to your financial records in connection with its consideration or administration of assistance to you in the form of a Government loan or loan guaranty agreement.
